

Returning to a user-friendly single-volume format, the Consumer Financial Services Answer Book continues to give readers a core understanding of the relevant laws, expert practice tips, and insight into emerging issues.

The new edition contains a fully updated chapter on Consumer Financial Protection Bureau (CFPB) Enforcement, explaining the Bureau's structure, the scope of its authority, the procedures it follows in enforcement investigations and actions, and what to expect and how to respond to CFPB investigations and enforcement actions. For those focused on mortgage lending and servicing, the new edition includes significantly updated chapters on the Real Estate Settlement Procedures Act, Mortgage Servicing Rules, and TRID, as well as Residential Foreclosures and Evictions. Revised chapters on Credit Cards, Military Lending and Loan Relief, and Fair Lending/Non-Discrimination address three other important coverage areas.
