In their award-winning piece, "[Ohio Appellate Decision Tackles Excluded Coverage for Marijuana Use](#)," Douglas, Heidi, and Lauren combined their respective tax, cannabis, and insurance knowledge to discuss this nuanced topic. The article was published in the Spring 2023 edition of *the Federation of Regulatory Counsel (FORC) Journal of Insurance Law and Regulation*. Cleveland* on insurance coverage, gives an overview of alcohol exclusion laws, and outlines the possible avenues to address damages caused by marijuana impairment.
