to Louisiana. In these cases, in which oil and gas companies have drilled and managed wells for years, landowners file claims over historical damage to the property and groundwater after the companies shut down operations. Some of the cases are massive, involving dozens of oil and gas enterprises. Rick foresees a potential new generation of this type of litigation, which will likely involve fracking activities.

In a series of complex cases, Rick represented the State of Louisiana, which sued several big oil companies in the wake of allegations involving a reimbursement fund. He enjoyed the collegiality of that experience, where both sides were working towards resolution and closure.
